How will becoming a Rights Respecting School benefit my child(ren)?	This approach works in many schools across the country to improve well-being and develop every child's talents and abilities to their full potential. Headteachers from schools involved in the Award say it has improved children's and young people's respect for themselves and others and contributed to children and young people being more engaged in their learning.
How can I get involved?	We hope you will support the school's journey to become a Unicef UK Rights Respecting School.
What is the Convention on the Rights of the Child?	In 1989, governments worldwide promised all children the same rights by adopting the UN Convention on the Rights of the Child. The Convention recognised that all children have the right to be treated with dignity and fairness, to be protected, to develop to their full potential and to participate. The rights in the Convention describe what a child needs to survive, grow, and live up to their potential in the world. They apply equally to every child, no matter who they are or where they come from.  The Convention changed the way children are viewed and treated – in other words, as human beings with a distinct set of rights instead of as passive objects of care and charity. It is the most widely ratified human rights treaty – only the United States has not ratified it. The UK signed up to it in 1991.  You can read more about it at www.unicef.org.uk/crc and download a
